- 與 閣下進行交易或建議進行交易之任何其他人士或機構, 例如 閣下之銀行、律師、會計師、持牌證券交易商或註冊 證券機構:及
- 要約人及/或摩根大通及/或維達及/或購股權要約結算 代理認為必需或適當情況下之任何其他人士或機構。

4. 獲取及更正個人資料
