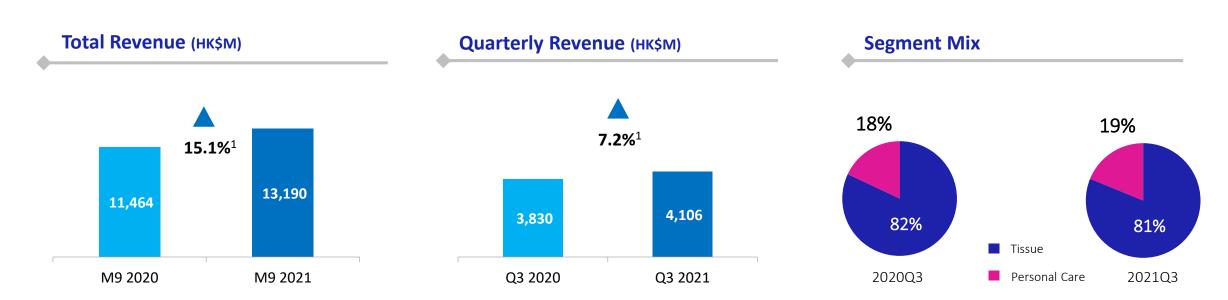

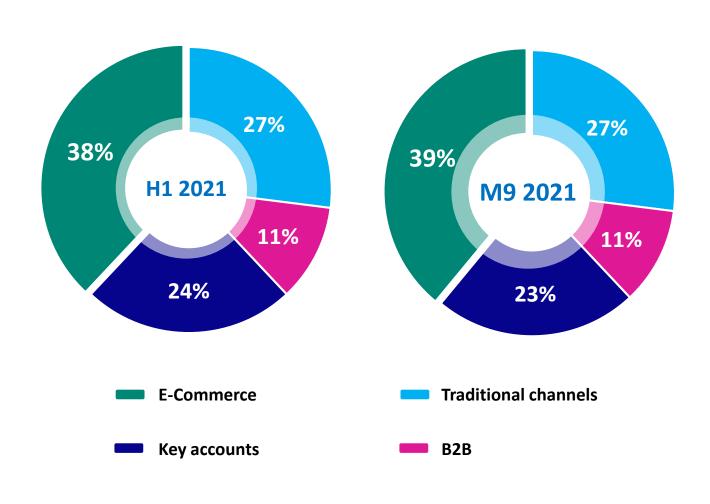

Group Revenue by Channels





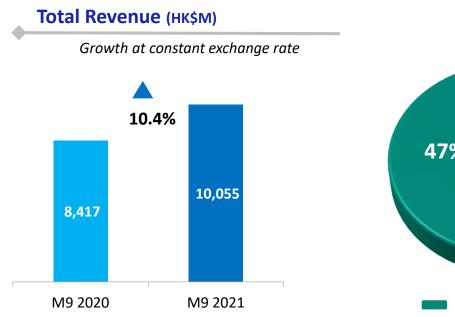


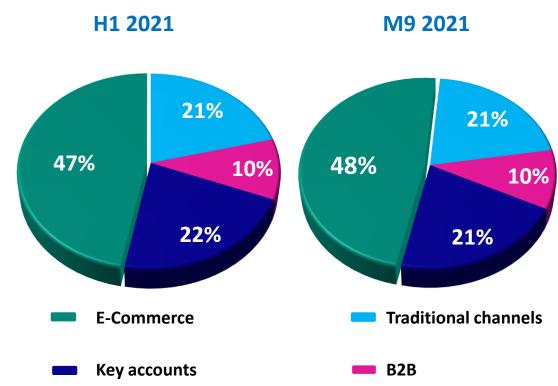




Mainland China Revenue and Channel Mix



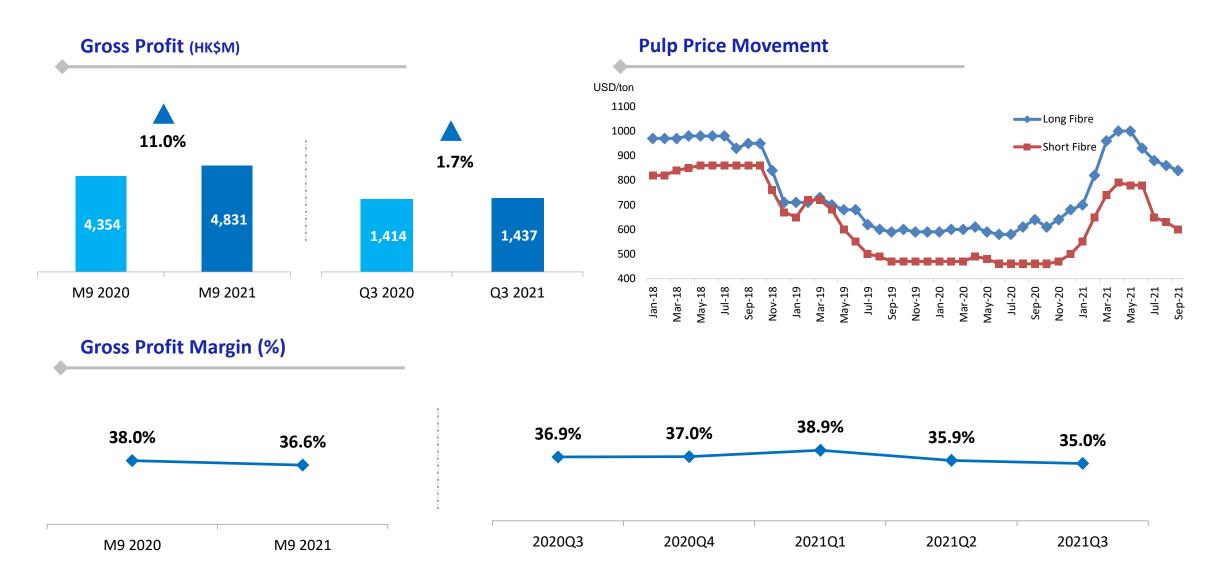






Gross Profit

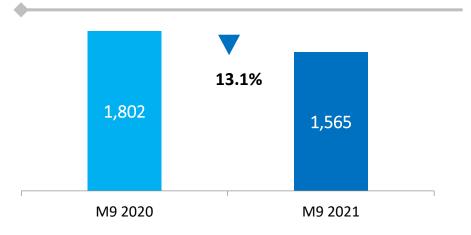


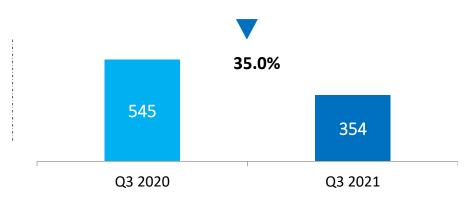


Operating Profit

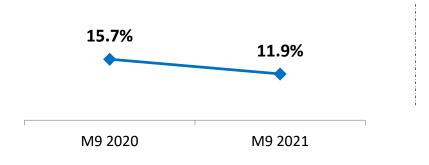


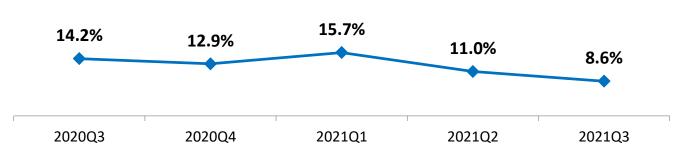
Operating Profit (HK\$M)





Operating Margin (%)



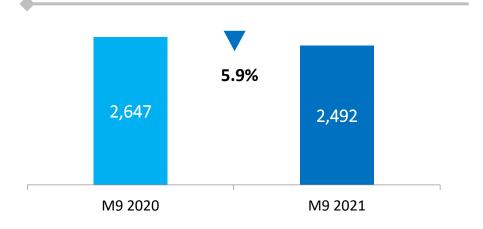


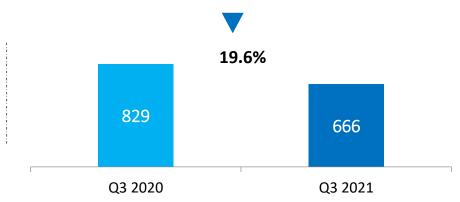

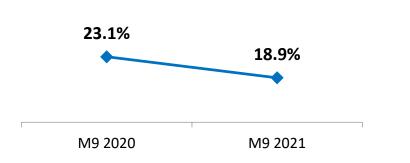

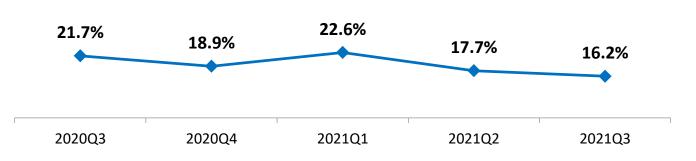
EBITDA (HK\$M)
